According to the American Cancer Society, prostate cancer tends to run in some families, which suggests, in some cases, there may be an inherited or genetic factor. Still, most prostate cancers occur in men without a family history of it.

Having a father or brother with prostate cancer more than doubles a man's risk of developing this disease. (The risk is higher for men who have a brother with the disease than for those who have a father with it.) The risk is much higher for men with several affected relatives, particularly if their relatives were young when the cancer was found.

The Young family from Jasper knows all too well about the statistics related to prostate cancer. Jeff Young has graciously agreed to share his story with us about his family history and the care he has received from Dr. Kris Gunn, Urologist with Daviess Community Hospital.

Jeff was born and raised in Jasper, Indiana. Life took him to other parts of the country while he was in the Air Force until his retirement in 1995 when he brought his family back to his Indiana roots.

After settling back into life as a Hoosier, Jeff then spent another 21 years with the Jasper City Police Department until his second retirement in 2016.

In recent years, Jeff and one of his sons have kept busy with "flipping" houses for various family members.

"On my dad's side of the family, most men since my grandfather have had prostate cancer," Jeff said. "My grandfather was 63 years old when he died from it, my dad was 59 years old when he was diagnosed with it. All four of my dad's brothers have had it, and now a first cousin has been diagnosed with it as well."

"When my dad was diagnosed, my mother made it her mission to research the best doctors and treatments for prostate cancer," Jeff recalled. "She identified a doctor at Barnes-Jewish Hospital/Washington University in St. Louis, MO, named Dr. William Catalona (aka "the father of PSA testing")."

As a mother of four sons, Jeff's mom then became an advocate for them and encouraged them to have PSA testing while also providing them with educational materials on the subject.

Fast forward to 2012 when Jeff discovered he had an elevated PSA level during an annual exam. "About the same time I was planning to schedule an appointment with a urologist, my dad went to a seminar featuring Dr. Kris Gunn," Jeff said. "When my dad learned that Dr. Gunn was a resident at the same university hospital where Dr. Catalona had taught, he insisted that I make an appointment with him."

Every time I came back to see him, Dr. Gunn and I had great conversations," he said. "He has such a great rapport with people and really cares about what you're going through.

I have 100% confidence in him if there is an issue, he will find it.

Jeff was immediately impressed by Dr. Gunn's knowledge, compassion and approach to a care plan. "Dr. Gunn treated me as an individual and did not sugar coat the risks associated with the elevated PSA," he said. "He respected whatever decision I made after giving me all options."

Based on his family history, Jeff firmly believes it is a matter of "when", not "if" he will be diagnosed with prostate cancer. In 2013, Dr. Gunn performed the first biopsy, which was negative. In 2015, a second biopsy was performed which also came back negative.

Jeff's PSA levels were up again this summer. This time, a 4Kscore was performed and the results came back as "low risk". The 4Kscore combines four prostate-specific biomarkers with clinical information to provide man with an accurate and personalized measure of their risk for aggressive prostate cancer.

Jeff has returned on a regular basis since 2012 to be tested and visit with Dr. Gunn. "Every time I came back to see him, Dr. Gunn and I had great conversations," he said. "He has such a great rapport with people and really cares about what you're going through. I have 100% confidence in him if there is an issue, he will find it." Dr. Gunn is the first to admit he does not want to find any cancer in any of his patients, but he also knows early detection is the best way to fight it.

Dr. Gunn remarked, "Jeff has done a great job of sticking to the follow up appointment schedule and wants to stay ahead of any changes in his health. I have had patients who do not take their PSA numbers and family history seriously until cancer is discovered."

Jeff also has great things to say about Dr. Gunn's staff. "I have the best care whenever I go to the office," he said. "They are all very polite, caring and treat me like one of the "family"."

Both Dr. Gunn and Jeff highly recommend that all men get a baseline PSA, especially if there is a family history of prostate cancer.

## DAVIESS COMMUNITY HOSPITAL RECEIVES HEALTH ISSUES & CHALLENGES GRANT

Daviess Community Hospital announced they have received a grant totaling \$933,300 from the Indiana Department of Health to establish a Community Paramedic Program as part of the state's Health Issues and Challenges program, which was established by the Indiana General Assembly in 2021 with funding from the American Rescue Plan Act.

The Community Paramedic Program is a patient-centered model of care delivered in a patient's home. This includes working with a team to coordinate in-home visits as well as the use of telehealth. The Community Paramedic will assist with health screenings, vaccinations, treatments and follow-ups. The program will also include social work, substance abuse resources, mental health, chronic disease management and more.

"DCH EMS being awarded this grant provides an exciting opportunity for us to further expand the skill set of our paramedics, and to further their reach into the community to address some of our population's most pressing health and wellness challenges," said Keith Miller, COO at Daviess Community Hospital. "Being able to expand the capabilities of our paramedics to address more primary and preventative health needs of our community will increase resources for atrisk Daviess county residents, and help us on our journey towards a healthier community."

Daviess Community Hospital is one of more than 150 entities to receive funding for the Health Issues and Challenges program, which focuses on the following priority areas: tobacco use, food insecurity/ obesity, lead exposure, hepatitis C, chronic disease, public health prevention programs, and substance use disorder and community health workers. Priority was given to applicants that demonstrated high need and high impact in their grant proposals.

The state awarded more than \$35 million statewide in the initial round of funding.

## DCH AWARDED SUBSTANCE MISUSE PREVENTION AND MENTAL HEALTH PROMOTION SERVICES GRANT

The Division of Mental Health and Addiction was awarded a grant through the American Rescue Plan Act of 2021 funding through the Substance Abuse and Prevention and Treatment Block Grant Program. Daviess Community Hospital is pleased to announce that they recently received a portion of this funding for programs to address needs through the Substance Abuse and Mental Health Promotion Services for Older Adult Populations (50+).

This two-year grant requires that DCH identifies a specific group of people over the age of 50 years who reside in public housing and provide them with monthly educational and health-related activities. A grant coordinator, clinical coordinator and project director have been identified and are working with other organizations to create meaningful events.

Daviess Community Hospital was required to work with a local cross-functional team. Daviess Community Hospital has selected to partner with DCH Transitions, DCH Peer Recovery, Washington Housing Authority, Retired Senior Volunteer Program, Daviess County Health Department, and Senior and Family Services. These relationships will be vital in building relationships with individuals and producing lasting change within the community.

DCH has identified the need for the aging population to access mental health and substance use prevention education and resources. As part of this prevention implementation, special focus will be given to community areas considered high risk for mental health and substance use.

## DAVIESS COMMUNITY HOSPITAL WELCOMES CHRISTY BREITWEISER, FNP-C



## INJURY LANDS JO ARTHUR IN THE EMERGENCY DEPARTMENT

February 8th had been an ordinary day for the Arthur family. Jo Arthur had just come home from an afternoon of playing cards with her friends. One of her sons was napping and her husband, Bob, was reading in the family room.

As Jo walked from the front door toward the back of the house, she suddenly fell to the floor. There was no logical explanation as to why she fell. As soon as Jo was able to look at her foot, she realized that it was not in its normal position. "My right foot was sideways with a bone coming out of the ankle," Jo recalled.

Her husband, Bob, heard the fall and came to see what happened. "He took one look at my foot, and immediately called 911," she said. "My son came out to see what was going on. He took one look at my foot and later passed out."

Soon after Bob made the 911 call, a Washington Fire Department crew and DCH EMS arrived. Jo recalls that one of the firemen was holding her foot as the EMS crew prepared to place her on a stretcher. "The first responders did a wonderful job in getting me to DCH."

Fortunately, the shock of what Jo experienced prevented her from feeling any pain.

When Jo arrived at the Daviess Community Hospital emergency department, her condition was immediately assessed and the Orthopedic team was called in.

Andy Houchins, Physician Assistant, was first to arrive to meet with Jo. "There was an initial irrigation, IV antibiotics, reduction and splinting under IV sedation in the ER which is important for initial trauma management," said Houchins. "While that was happening, I had already put the wheels in motion for the OR team to come in. As soon as Dr. Thorne arrived and visited with the patient, we went straight to the OR from the ER and performed trauma-level center care. Jo had a significant fracture, but surgery went very well and she did amazingly well."

"When I met with Jo, I explained to her that a woman her age doesn't typically have this kind of complex fracture," Dr. Thorne recalled. "I have only seen this type of injury in basketball players who come down from a jump and land on their ankle instead of their foot."

Jo is still puzzled as to why the break happened. She has never had a broken bone and has no issues with osteoporosis. She is very grateful that she did not also break an arm or wrist when she fell.

Following surgery, Jo was moved to the Acute Rehab floor at Daviess Community Hospital where she began a twelve week stretch of "no weight bearing".

"The Acute Rehab team was wonderful!" she exclaimed. "I was there for nine days and learned so much about how to manage around the house when I went home and how to use a knee scooter and walker to get around. They also emphasized the importance of keeping my good leg strong." Friends of the Arthurs made sure a ramp was built in time for her homecoming. She found that sleeping in a recliner was the most comfortable position as her ankle healed.

Soon after her release from DCH Acute Rehab, Jo began therapy sessions at the DCH CORE Center.

Dr. Thorne was concerned about the damage to her tendons and the healing process. Her cast was taken off on March 1st and she graduated to a walking boot with home exercises assigned for the next several weeks. Jo was delighted to graduate from the boot in early May and to complete her therapy in July.

Jo was thankful that she was able to enjoy time at the beach this summer with her family. "Walking in the sand was a little tricky, but I am grateful I was able to enjoy a vacation without a walker or cane," she said. "I am so grateful to the DCH team for taking great care of me and getting me back to my active lifestyle."
